The meeting was called to order by Mr. Dennis Reaves, Chairman.

#### **OLD BUSINESS:**

Minutes of the CAC meeting of May 17, 2016, were approved on a motion by Mr. Marshall Shaddix and seconded by Mr. Steve Akers. Motion carried.

Chairman Reaves welcomed new member from the City of Anniston, Mr. Miller Parnell, then stated that Anniston, Oxford and Hobson City needed to fill vacant CAC positions, and asked that all members talk with their mayors to help fill the vacant positions.

#### **NEW BUSINESS:**

Chairman Reaves opened the Public Involvement Meeting to discuss a Formal Amendment to the FY 16-19 TIP. Mr. Plunk gave the members a handout to review and explained that the ALDoT had requested that the MPO delete two projects; (CN) ATRIP Bridge Replacement on Choctaw Street

for the County and (CN) Turn Lanes/Intersection/Bridges L. Smith Parkway for the City of Oxford, then add (CN) Turn Lanes/Intersection/Bridges L. Smith Parkway for the City of Oxford. He also explained that when a project is added or deleted to the TIP, a formal amendment process, which includes an opportunity for public review and comment. We have announced today's meeting with the block ad announcement in the Anniston Star on July 14<sup>th</sup> and 15<sup>th</sup>, and also mailed to all of the CAC member and media contacts. Therefore, that is the reason for the public involvement meeting today. Mr. Plunk explained to the members that there was a comment form on the back of the handout for anyone that would like to comment on the proposed amendments. He mentioned the public meeting will be held open until the end of the CAC meeting in case some members of the public arrived late.

Next, Chairman Reaves called for the Review of FY 16-19 TIP Update. Mr. Plunk gave the members a handout of the list of projects and balance of MPO funds to review. Several authorized projects are in the PE development stage and a couple more are in RoW, which are indicated in green. The projects in yellow are the projects that have been shifted from one FY to another with the additional 1% added to the cost, projects highlighted in blue have had a recent adjustment in allocation, and the projects highlighted in pink are ATRIP or ARRA funded. The balance of funds is still low for FY 18, but the balance of funds is in a positive status.

Chairman Reaves continued by calling for discussion of MPO Projects Current Under Construction. Mr. Plunk explained that on page 5 in the agenda packet is a list of eight projects that have been let for construction in 2016. He explained that at this same time last year, there was only one project in construction.

Next, Chairman Reaves called for the discussion of the National Infrastructure Investment at a 30-Year Low. Mr. Plunk gave the members an article from The Fiscal Times published on February 25<sup>th</sup> titled "As Roads Crumble, Infrastructure Spending Hits a 30-Year Low" to review. Total capital spending as a share of state GDP fell in all but five states and the District of Columbia between 2002 and 2013, with the largest drops in Nevada, Florida and Michigan. According to the 2013 infrastructure report card by the American Society of Civil Engineers, the U.S. has serious infrastructure needs of more than \$3.4 trillion through 2020, including \$1.7 trillion for roads, bridges and transit; \$736 billion for electricity and power grids; \$391 billion for schools; \$134 billion for airports; and \$131 billion for waterways and related projects.

Chairman Reaves continued with New Business by calling for the discussion of Global Shipping Routes to Change. Mr. Plunk gave the members an article from The Anniston Star published on June 26<sup>th</sup> titled "Overhaul May Change Global Trade Routes" to review. The article explains the \$5.25 billion expansion to the Panama Canal is expected to double the canal's capacity, tap new markets and cut global maritime costs by an estimated \$8 billion a year. This project, nine years in the making, is aimed at boosting the competitiveness of the 50-mile shortcut between the Atlantic and the Pacific and maintaining its ability to generate billions of dollars a year for the Central American nation. Mr. Plunk said that this means that our roadways and interstates will have more truck traffic and our section of I-20 already has an extremely high truck counts. Our truck percentage is around

40% where others are at 15%. This will cause more damage to our roads and means more infrastructure repair.

Mr. Jerry Lewallen brought up the US 78/Anniston Industrial Park intersection and stated that it was dangerous and congested in the afternoon, when employees were leaving the Industrial Park, and also that there were frequent accidents. Mr. Plunk mentioned that he would again contact the City of Anniston and the ALDoT about his area.

### **OTHER BUSINESS:**

Mr. Plunk briefly reviewed the status report of the current local ALDoT sponsored projects, which were included in the agenda for review.

Chairman Reaves called for the report on Anniston Express and ADA Para-Transit Ridership. Mr. Plunk stated that there was a total of 9,745 riders for June. For the ADA Paratransit Ridership for June; Anniston had 689 one-way trips, Jacksonville had 276 one-way trips, no trips for Weaver, and Oxford had 205 one-way trips. For the Urbanized area 383 one-way trips and 307 one-way trips for the Rural area.

The next CAC meeting is scheduled for Wednesday, September 21, 2016, at 10:00 a.m. in the EARPDC 3<sup>rd</sup> floor Conference Room.

There being no further business, Chairman Reaves pronounced the Public Meeting closed and the CAC meeting was adjourned.







## **ACTIVE LIVING:** A PLANNING SUBFIELD COMES OF AGE

N A COLD AND RAINY NIGHT IN THE WINTER OF 2000, a subfield of urban planning was born. Actually, it may have been balmy night in the summer of 2001. I have no memory of the weather or even the year, but I do recall what happened that evening.

A group of urban planners, public health experts, and Robert Wood Johnson Foundation staff had gathered at the RWJF headquarters in Princeton, New Jersey. RWJF had decided to shift its emphasis from tobacco control to physical activity promotion and obesity prevention. The decision was timely. Smoking rates in the U.S. were falling, while inactivity and obesity rates were rising.

RWJF had organized the meeting to lay the foundation for a three-part initiative to create better environments for active living: Active Living Research was the research program; Active Living by Design was the action program; and Active Living Leadership worked to engage leaders in implementing the lessons from the other two programs.

RWJF had learned a lot from the smoking wars, specifically that individual exhortations and appeals were less effective than policy and environmental changes. RWJF was instrumental in getting smoking banned from public places and enacting sharp increases in taxes on cigarettes. The reduction in smoking is attributable to these types of measures far more than public information campaigns.

So RWJF applied the same logic to physical activity promotion and obesity prevention. The conceptual model they posited, at that time, went like this: The built environment

of the U.S. has become increasingly carcentric, and levels of physical activity have correspondingly declined. Reduced physical activity, and constant or increasing calories, has resulted in population weight gains. Therefore, to counter these trends, it is necessary to make communities more conducive to physical activity once again, particularly walking and cycling.

Planners were invited to the table because we, as a profession, exercise (pun intended) the greatest influence on the built environment of any profession (except perhaps land developers).

#### Meeting of the minds

We sat around a dinner table that evening-a somewhat ironic setting, considering the topic—and discussed our respective fields. I was surprised to learn

that public health experts were doing research on the built environment and physical activity that roughly paralleled what was happening in urban planning. In the early 1990s, planners had begun to study the effects of the D variables (development density, land-use diversity, street design, etc.) on walking, bicycling, and transit use. Meanwhile, physical activity researchers were studying the effects of park space, trails, playgrounds, and other recreational facilities on exercise and leisure-time activity. We were in roughly the same business and had all reached roughly the same conclusion: the built environment matters.

Jim Sallis, then of San Diego State University and now at University of California, San Diego, was a leader that evening. He would later head the Active Living Research Program. Kate Kraft was there as well. She later came to coordinate RWJF initiatives and now directs the America Walks Coalition.

In the ensuing years, RWJF pumped millions of dollars into these three programs. Then, about five years later, RWJF shifted the focus to childhood obesity with an initial \$500 million commitment, incorporating the active living programs and adding healthy eating programs to the childhood obesity initiative.

#### Growing body of work

Fast forward to today. The work of planners has risen to the top of the agenda for U.S. public health. Indeed, the Surgeon General's recent call to action was about walking and walkability. When this effort started, no one in the health community knew what walkability was.

The amount of research on the built environment and public health that exists today is truly amazing. One of APA's three research centers is dedicated to this topic—the Planning and Community Health Center (planning.org /nationalcenters/health).

Our first research study on the built environment and obesity was published in 2003 (with funding from RWJF). A 2014 review of literature by J.D. Makenbach et al. published in *BMC Public Health* found more than 5,000 original articles published since then, examining associations between physical environmental characteristics and adult weight status. While the research is still maturing, the weight (another pun) of evidence backs up what we said back in 2003: Urban sprawl makes you fat, sick, and dead.

The earliest studies of the built environment and public health appeared in established journals such as the *Journal of* the American Planning Association and the American Journal of Preventive Medicine.

Since then, due to the volume of research, other journals have sprouted up. A favorite of mine is the *Journal of Transport* & *Health*, established in 2014. Its mission is to research the many interactions between transport and health.

In one article in the latest issue (vol. 3, issue 2) by Langlois et al. (tinyurl.com /zyphpbz), the authors conducted surveys of residents living in seven transit-oriented developments in North America: Rosslyn Station, Arlington, Virginia; South Orange Station, South Orange, New Jersey; Berkeley Station, Berkeley, California; Mockingbird Station, Fort Worth, Texas; Downtown Plano Station, Dallas; Equinox Station, Toronto; and Joyce-Collingwood Station, Vancouver, British Columbia.

They found that individuals who use public transportation are more likely to achieve recommended levels of physical activity than those who do not. Pedestrian friendliness of the residential location, affordability of public transport, and good weather all had positive effects.

It has been said more than once that planning has its roots in public health ("health, safety, welfare"). Now, after decades of planning for the automobile, we have finally come full circle.

## Circular Pedestrian Bridge in Lujiazui, China

Sometime last year, a new pedestrian bridge was unveiled in Lujiazui in the Pudong district of Shanghai. This large scale circular pedestrian overpass enables pedestrians to avoid traffic at the round-about terminus of Lujiazui Rd. The bridge provides access to the Oriental Pearl Tower connecting financiers to leisure areas such as shopping malls and cafes, a transit station and office buildings. The bridge sits almost 20 feet above the street, with numerous escalator stairway entrances and exits. The very contemporary design and long spans between columns provides a pleasant street level experience. Visitors enjoy the walkway for its privileged views of the city as well as its introduction of clean and easy foot transportation. At night the structure is illuminated to great dramatic effect.

The walkaway is 5.5 meter high and can fit 15 people walking side by side. Since it's opening, it has become quite a tourist attraction.
