The meeting was called to order at 10:03 a.m. by Ms. Libby Messick.

Upon reviewing the minutes of the April 8, 2020 meeting, a motion to approve the minutes was made by Mr. Fred Denney and was seconded by Mr. Mark Stephens. Motion carried.

#### **OLD BUSINESS:**

Mr. Fred Denney and Steven Corley discussed the funding agreements for the PE portions of the Friendship Road projects. Mr. Mark Stephens asked about the geotechnical portion of the Mountain Street project to which Michael Bergh responded they are expecting it to be complete sooner than the three-month expectancy. Mr. Toby Bennington gave an update on the right-of-way acquisition for the Anniston Chief Ladiga Trail.

### **NEW BUSINESS:**

Ms. Messick called for review of the FY 20-23 TIP Spreadsheet and Administrative Modifications. She gave the members handouts of the list of MPO projects and reviewed the Administrative Modifications for the month. Ms. Messick explained that there was one modification that created changes on the TIP spreadsheet and one modification that did not create any changes to the TIP spreadsheet.

Ms. Messick then called for discussion of Resolution No. 803. The resolution was requested by the ALDOT that the MPO allocate an additional \$126,902.12 in CN for project number 4, Baltzell Gate Signal Upgrade (100047014). This resolution would bring the total allocated amount for this project to \$453,734.12. A motion was made by Mr. Toby Bennington to approve this request with **Resolution No. 803**, which was seconded by Mr. Mark Stephens. Motion carried.

Next, Ms. Messick called for discussion of Status Report of ALDOT projects. Ms. Messick read the report submitted by Mr. Shane Brown and included in the agenda packet. She detailed Snow Street was punch list items, Bridge painting projects were waiting on punch list items and on-going claims,

Mountain Street resurfacing had pipe liner installed and a small section of liner should be repaired this week and concrete should start next week, and the AL-144 resurfacing and widening from St. Clair County line to US 431 is anticipated to begin June 1.

Next, Ms. Messick continued by calling for discussion of Safety Observations. She explained that there was a handout in the agenda packet with the list of concerns from the CAC that had been discussed at previous meetings for review. She explained she would confirm item number 19 with the CAC the following week regarding a which west-bound 431 exit ramp and SR-21 intersection had difficulties with merging. Mr. Mark Stephens provided an update for item number 20 that Mayor Smith had confirmed the signalization of White's Gap and SR-21 had previously been denied due to its proximity to other signalized intersections. They would follow up with Shane Brown.

Next, Ms. Messick called for the Report on Urban Fixed Route and ADA Handicapped Transit Systems. She gave the report for the Fixed-Route ridership for the month of April, which was provided in the agenda packet for review. There were 4,285 passengers on the Fixed-Route which was a severe decrease from the previous month and decrease from the previous year due to COVID-19 restrictions. The final table in the agenda is the ADA Paratransit ridership for the month of April. There were 771 trips for the City of Anniston (decrease), 104 trips for the City of Jacksonville (decrease), 57 trips for the City of Weaver (decrease), 161 trips for the City of Oxford (increase), 64 trips for the Urbanized part of the County (decrease) and 60 trips for the Rural part of the County (decrease).

The next TAC meeting will be Wednesday, June 10, 2020 at 10:00 a.m.

There being no other business to discuss, the meeting was adjourned at 10:24 a.m.
