The meeting was called to order at 10:02 a.m. by Mr. Tim Huddleston, Vice Chairman.

OLD BUSINESS:

Minutes of the CAC meetings from March 16, 2022, were approved on a motion by Mr. Bruce Britton and seconded by Mr. Richard Lindblom. Motion carried.

Vice Chairman Huddleston called for discussion of April 2022 Administrative Modifications and Resolutions. Ms. Messick explained that there was a list of modifications in the agenda packet to review that were discussed during the month of April to keep the members of the CAC up to date. There were three modifications that created changes to the TIP and four modifications that did not create changes to the TIP spreadsheet in April. Ms. Messick also reported the one resolution adopted in April.

NEW BUSINESS:

Vice Chairman Huddleston called for the Review of FY 20-23 TIP Update and Administrative Modifications. Ms. Messick gave the members a copy of the current TIP. There were two administrative modifications that made changes to the TIP Spreadsheet and one administrative modification that did not create changes to the spreadsheet.

Vice Chairman Huddleston next called for discussion of Status Report of ALDOT projects. Ms. Messick reported the US-431 access management project was working on punch list items and awaiting final acceptance. The Church Ave resurfacing is awaiting final acceptance with only share rows remaining. The I-20 resurfacing project is working on punch list work and awaiting final acceptance. AL-9 resurfacing project is placing guardrail installation and awaiting final

acceptance. US-431 resurfacing from south of SR-204 to the Etowah County line has completed mainline milling operations and will be placing upper binder around the first of June.

Vice Chairman Huddleston continued by calling for discussion of Safety Observations. Ms. Messick explained that there was a list of previous observations in the agenda packet for review. Ms. Messick explained the only update was to new item #26 where Mr. Mark Stephens had reported a developer is interested in that area. They are currently waiting on a commitment from the developer and entrance/exit placement before requesting a warrant study from ALDOT. Mr. Bruce Britton initiated discussion on the entrance of the new Jack's in Golden Springs. His concern was this entrance would cause a bottleneck and hinder traffic. Ms. Messick stated she would discuss with Anniston's City Engineer.

OTHER BUSINESS:

Vice Chairman Huddleston called for discussion of CAC vacancies. Anniston has 9 vacancies, Jacksonville has 1, Oxford has 7, Weaver has 1 vacancy, and 1 for Hobson City.

Next, Vice Chairman Huddleston called for the report on Urban Fixed Route and ADA Handicapped Transit Systems. Ms. Messick reported the ADA Paratransit Ridership for Anniston had 525 (decrease) one-way trips, Jacksonville had 129 (decrease) one-way trips, 10 trips for Weaver (decrease), and Oxford had 109 (decrease) one-way trips. For the Urbanized area 70 (decrease) one-way trips and 108 (increase) one-way trips for the Rural area. Fixed-route ridership had a total of 8,965 (increase) riders for the month of April.

The next CAC meeting was scheduled for Wednesday, July 20 at 10:00 a.m.

There being no further business, a motion was made by Mr. Bruce Britton and seconded by Mr. Richard Lindblom to adjourn. The meeting was adjourned at 10:37 a.m.
