### **Projects Proposed to Let November 3, 2023**

#### **Calhoun County**

❖ NH-HISP-0021(581) for constructing the safety widening, micro-milling, resurfacing (scrub seal), bridge rail retrofit, guardrail installation, and traffic stripe on SR-21 from the Talladega County Line to 0.409 miles north of Snow Street (MP 251.963) in Oxford. Project length 2.782 miles. The bracket estimate on this project is from \$3,048,763 to \$3,726,265.

#### **Chambers County**

❖ RACR-009-015-004 for constructing the roadway improvements/concrete paving project (grading, drainage, and pavement) on SR-15 (US-29) from the South exit ramps (MP 209.851) over I-85 to the North exit ramps (MP 210.040) near the Georgia State line. Project length 0.236 miles. The bracket estimate on this project is from \$4,686,848 to \$5,667,259.

#### **❖ DOT Opens Thriving Communities Technical Assistance Program**

The U.S. Department of Transportation (DOT) <u>announced</u> the second round of its <u>Thriving Communities</u> <u>Program (TCP) (FY 2023)</u> (<u>www.transportation.gov/grants/thriving-communities</u>) to support low-resourced communities in advancing transformative transportation projects. Communities in need of free technical assistance can submit a Letter of Interest by **November 15**. To learn more, visit the <u>Information for Communities webpage</u> (www.transportation.gov/grants/thriving-communities/information-for-technical-assistance-seekers). **New for 2023**: Technical Assistance Providers can apply for funding to offer assistance to communities within their regions or at the national scale. Regional technical assistance funding could provide an opportunity for coalitions of RDOs, state RDO associations, or other providers to help their communities conduct planning, pre-development, grant application activities, or other assistance. Read about both the National-level and Regional-level capacity building opportunities on the <u>Information for Capacity Builders webpage</u> (www.transportation.gov/grants/thriving-communities/information-for-capacity-builders). Capacity builder applications are due **November 28**.

- ❖ In partnership with Main Street America and Smart Growth America, T-Mobile is committing \$25 million toward small-town grants over the next five years through its <a href="Hometown Grants program">Hometown Grants program</a>. The program will award up to 100 towns per year with project funding grants of up to \$50,000 each. The program will focus on revitalizing community spaces in towns with 50,000 people or less. Main Street programs are encouraged to apply. - The U.S. Department of Agriculture (USDA) Rural Development is seeking applications for loans and grants to support rural water and waste disposal systems. Applications are accepted year-round, and technical assistance is available. USDA's <a href="Water and Environmental Programs">Water and Environmental Programs</a> can assist with constructing or improving infrastructure through loans, grants, and loan guarantees. USDA can also partner with rural water and waste service providers to finance infrastructure that aims to protect the cyber security of their facilities. The Water and Environmental Programs at USDA were recently expanded, and guaranteed loans are now available to smaller communities that have the financial strength to take advantage of conventional credit as well as larger communities with populations of up to 50,000. USDA also has technical assistance resources available through partnering organizations. USDA's resources are not limited to communities that have already received a loan or grant through Rural Development. Any water or waste disposal system in an eligible rural area may benefit from technical assistance. For more information on the resources available reach out to your local <a href="USDA Community Program Specialist">USDA Community Program Specialist</a>. Applications can be submitted through RDApply (https://www.rd.usda.gov/programs-services/rd-apply).
- The Federal Highway Administration (FHWA) and Alabama Department of Transportation (ALDOT) have announced calls for the Traffic and Safety Operations Section's (TSOS) Highway Safety Improvement Program (HSIP) applications. Deadlines are April 1st, July 1st, October 1st, and January 1st. Max funding amount per agency for reducing rural land departures is \$2,000,000; for intersection-related projects is \$2,000,000, and for safe transportation for every pedestrian (STEP) is \$200,000. They are also announcing a new Local Roads Safety Initiative within the Alabama HSIP. The initiative will be open to cities and counties for both rural and urban non-state maintained roadways with significant safety risks. Applications submitted through this initiative must be in accordance with the most recent Alabama Strategic Highway Safety Plan and applicable Local Road Safety Plans if one has been developed by the county that the location falls within. The TSOS is also making available Road Safety Review (RSR) services for those cities or counties that have an identified location(s) but would like some assistance in ensuring the

most effective countermeasures are chosen. Applications under this initiative will be submitted electronically to the ALDOT State Traffic and Safety Operations Engineer. PE, ROW, UT, and CN phases are eligible for funding but may make the application less competitive compared to those with only CN phases requested. - ❖ The Environmental Finance Center Network is offering technical assistance free of charge to small drinking water systems serving 10,000 or fewer people. Services include a resource help desk, financial health check-up, water and wastewater rates analysis tool, and a financial resilience dashboard. - Community Heart & Soul is offering \$10,000 in Seed Grant Funding to small cities and towns. This program provides startup funding for resident-driven groups in communities with populations of 2,500 30,000 to implement the Community Heart & Soul model which engages the entire population of a town in identifying what they love the most about their community, what future they want for it, and how to achieve it.
