After roll call was taken and it was determined that a quorum was present, Vice Chairman Jenkins called the meeting to order at 10:02 a.m.

OLD BUSINESS:

The minutes of the May 18, 2023, meeting was approved on a motion made by Mr. Fred Denney and seconded by Mr. Mark Stephens. Motion carried.

NEW BUSINESS:

Chairman Jeff Clendenning called for the Review of FY 20-23 TIP Spreadsheet and Administrative Modifications. Ms. Messick explained that there were eight administrative modifications that created changes on the TIP spreadsheet and one administrative modification that did not create changes to the TIP spreadsheet.

Chairman Jeff Clendenning then called for discussion of Resolution No. 852. Ms. Messick explained this resolution was to support the City of Oxford in their TAP Application for sidewalk improvements along McKibbon Street and Thomas Street. Ms. Messick explained the funding for this project would have no impact on MPO funding but must be included in the TIP as it is in the MPO area. A motion was made by Mr. Mark Stephens to approve this certification with **Resolution No. 852**, which was seconded by Mr. Fred Denney. Motion carried.

Chairman Jeff Clendenning then called for discussion of Resolution No. 853. Ms. Messick explained this resolution was to support the Jacksonville State University in their TAP Application for constructing a raised landscaped median along SR-21, new ADA compliant sidewalks at the intersection of SR-21 and SR-204 and the removal of a midblock crosswalk west of the intersection. Ms. Messick explained the funding for this project would have no impact on MPO funding but must be included in the TIP as it is in the MPO area. A motion was made by Mr. Fred Denney to approve this amendment with **Resolution No. 853**, which was seconded by Mr. Mark Stephens. Motion carried.

Chairman Jeff Clendenning then called for discussion of Resolution No. 854. Ms. Messick explained this resolution was to amend the 2045 LRTP to include two projects for the City of Jacksonville for fiscal years 2028 and 2029. She further explained that should funding be available later in the TIP, these projects could be moved ahead of schedule once added to the LRTP. A motion was made by Mr. Fred Denney to approve this amendment with **Resolution No. 854**, which was seconded by Mr. Mark Stephens. Motion carried.

Chairman Jeff Clendenning next called for discussion CAC Appointments. Ms. Messick reported that there was a list of the members in the agenda packet to review. The City of Anniston needs 9 appointments, 8 for the City of Oxford, and 1 for Jacksonville.

Next, Chairman Jeff Clendenning continued with New Business by calling for discussion of Safety Observations. Ms. Messick explained that there was a handout in the agenda packet with the list of concerns from the CAC that had been discussed at previous meetings for review. There was only one item with any updates and that was item #6 which had been requested to be reopened by Councilman Jay Jenkins. No further updates were available.

OTHER BUSINESS:

Chairman Jeff Clendenning next called for discussion of Status Report of Pre-Construction projects. Mr. Michael Bergh reported project 41 is waiting on plan in hand plans, TS&L, and environmental, CE is not approved yet; project 48 60% plans submitted, draft materials report completed and will submit week of 6/12/23, habitat assessment completed and submitted; project 49 TS&L reviewed and will be resubmitted week of 6/12/23; geotechnical foundation submitted, 60% plans will be submitted after TS&L approval, and updated hydro cross sections is needed; project 50 is working on materials report and waiting on plan submission; project 57 needs to request a construction agreement; and project 33 is waiting on plan in hand plans.

Chairman Jeff Clendenning next called for discussion of Status Report of ALDOT projects. Mr. Shane Brown had submitted a report prior to the meeting that the US-431 resurfacing from south of SR-204, I-20 resurfacing from H.J. Bentley Jr. Overpass to Snow Creek, and Russell Drive resurfacing projects are all working on punch list work and awaiting final acceptance; the reconfiguration of intersection at US 78 and Barry St including resurfacing, widening, and signals has utility conflicts; and US 431 resurfacing from just north of SR-144 to 0.28 miles south of SR-204 has begun milling work and binder will begin in a couple of weeks.

Chairman Jeff Clendenning called for the Report on Urban Fixed Route and ADA Handicapped Transit Systems. Ms. Messick reported the ADA Paratransit Ridership for Anniston had 529 (increase) one-way trips, Jacksonville had 169 (decrease) one-way trips, 15 trips for Weaver (same), and Oxford had 54 (increase) one-way trips. For the Urbanized area 58 (decrease) one-way trips and 31 (decrease) one-way trips for the Rural area. Fixed-route ridership had a total of 7,509 (increase from last month; decrease from last year) riders for the month of May.

Chairman Jeff Clendenning called for discussion regarding the Draft Transit Study Review and Comment. Ms. Messick explained a draft copy of the Transit Study had been set out with the agenda packets for the committee's review. Any comments regarding the study would be taken until the end of the month, submitted to JRWA, and corrected for the final document.

Chairman Jeff Clendenning then called for discussion regarding the FY 24-27 TIP Public Involvement. Ms. Messick explained a public involvement meeting would be held July 12th from 4-5 pm for any comments on the FY 24-27 TIP projects as well as the projects added to the LRTP.

Finally, Chairman Jeff Clendenning called for comments or issues from member jurisdictions or attendees. Ms. Messick noted that the next meeting would fall on a day she would be out of town for the ATPA conference. She asked the members if they would like to cancel next month's meeting or push it back a week. Chairman Jeff Clendenning suggested to keep an eye out on if there is any business needing attending to that month, if there is not then the meeting could be cancelled and if there were any resolutions that needed immediate attention, the meeting could be pushed back a week. All agreed.

There being no further business, the meeting was adjourned at 10:21 am. The next meeting of the MPO will be tentatively Thursday, July 27 at 10:00 a.m.
