#### **MINUTES**

The meeting was called to order at 10:08 a.m. by Ms. Libby Messick.

Upon reviewing the minutes of the May 10, 2023, meeting, a motion to approve the minutes was made by Mr. Mark Stephens and was seconded by Mr. Fred Denney.

#### **OLD BUSINESS:**

There were no old business items to discuss.

#### **NEW BUSINESS:**

Ms. Messick called for review of the FY 20-23 TIP Spreadsheet and Administrative Modifications. She gave the members handouts of the list of MPO projects. Ms. Messick explained that there were eight administrative modifications that created changes on the TIP spreadsheet and one administrative modification that did not create changes to the TIP spreadsheet.

Ms. Messick then called for discussion of Resolution No. 852. Ms. Messick explained this resolution was to support the City of Oxford in their TAP Application for sidewalk improvements along McKibbon Street and Thomas Street. Ms. Messick explained the funding for this project would have no impact on MPO funding but must be included in the TIP as it is in the MPO area. A motion was made by Mr. Toby Bennington to approve this certification with **Resolution No. 852**, which was seconded by Mr. Mark Stephens. Motion carried.

Ms. Messick then called for discussion of Resolution No. 853. Ms. Messick explained this resolution was to support the Jacksonville State University in their TAP Application for constructing a raised landscaped median along SR-21, new ADA compliant sidewalks at the intersection of SR-21 and SR-204 and the removal of a midblock crosswalk west of the intersection. Ms. Messick explained the funding for this project would have no impact on MPO funding but must be included in the TIP as it is in the MPO area. A motion was made by Mr. Mark Stephens to approve this amendment with **Resolution No. 853**, which was seconded by Mr. Toby Bennington. Motion carried.

Ms. Messick then called for discussion of Resolution No. 854. Ms. Messick explained this resolution was to amend the 2045 LRTP to include two projects for the City of Jacksonville for fiscal years 2028 and 2029. She further explained that should funding be available later in the TIP, these projects could be moved ahead of schedule once added to the LRTP. A motion was made by Mr. Toby Bennington to approve this amendment with **Resolution No. 854**, which was seconded by Mr. Chris Gann. Motion carried.

Ms. Messick next called for discussion of Status Report of Pre-Construction projects. Mr. Matt Hawes reported project 48 had submitted 60% plans, a draft materials report was completed and will be submitted the following week, and the habitat assessment was completed and submitted; project 49 has had the TS&L reviewed and resubmitted; 60% plans and geotechnical foundation should be submitted once the TS&L is approved; and project 50 is working on a materials report. Mr. Chris Gann reported that project #55 has submitted plans and is on time for an August Let.

Ms. Messick next called for discussion of Status Report of ALDOT projects. Mr. Shane Brown had submitted a report prior to the meeting that the US-431 resurfacing from south of SR-204, I-20 resurfacing from H.J. Bentley Jr. Overpass to Snow Creek, and Russell Drive resurfacing projects are all working on punch list work and awaiting final acceptance; the reconfiguration of intersection at US 78 and Barry St including resurfacing, widening, and signals has utility conflicts; and US 431 resurfacing from just north of SR-144 to 0.28 miles south of SR-204 has begun milling work and binder will begin in a couple of weeks.

Ms. Messick then called for discussion of the FY24-27 TIP project preparation. She reported that by moving 5 projects out fiscal years achieved a positive for year 2025 and all years in the next TIP cycle. However, there are currently no projects scheduled for FY27. She requested any municipality that had a project in mind for this year to submit it prior to next month's TAC. Any projects not included in the LRTP would need to be included in that plan first before included in the TIP.

Next, Ms. Messick continued by calling for discussion of Safety Observations. She explained that there was a handout in the agenda packet with the list of concerns from the CAC that had been discussed at previous meetings for review. There was only one item with any updates and that was item #6 which had been requested to be reopened by Councilman Jay Jenkins.

Next, Ms. Messick called for the Report on Urban Fixed Route and ADA Handicapped Transit Systems. The report had not been generated for the TAB meeting but should be available for the MPO meeting the following week.

The next TAC meeting will be Wednesday, July 12, at 10:00 a.m.

There being no other business to discuss, the meeting was adjourned at 10:35 a.m.

WHEREAS, the Calhoun Area Metropolitan Planning Organization (MPO) is the organization designated by the Governor of the State of Alabama as being responsible, together with the State of Alabama, for implementing the applicable provisions of 23 USC 134 and 135 (amended Infrastructure Investment and Jobs Act, November 2021); 42 USC 2000d-14, 7401; 23 CFR 450 and 500; 40 CFR 51 and 93; and

WHEREAS, Title 23 CFR 450.316(a)(1) et al, requires that transportation projects in urbanized areas funded by the Federal Highway Administration and the Federal Transit Administration be included in a Transportation Improvement Program (TIP) and adopted annually by vote of the Calhoun Area metropolitan Planning Organization (MPO); and

WHEREAS, all public comments will be reviewed by the MPO and included in the final document; and

WHEREAS, consistent with the declaration of these provisions, the East Alabama Regional Planning and Development Commission (EARPDC), as staff to the MPO and in cooperation with the Bureau of Local Transportation, Alabama Department of Transportation, has prepared a Draft FY 2024-2027 Transportation Improvement Plan (TIP); now
